## Newsletter #15 will focus on: WGOS Service Insight: WGOS1 Smoking Cessation

***Service Insights occur three times a year and will cover a wide range. It is our opportunity to listen to those delivering WGOS, so that we are able to better support you.***

All practices performing WGOS must participate in three Service Insights each financial year. This forms part of the WGOS Quality Package, which is associated with a payment to Contractors. The other aspects of the WGOS Quality Package are Quality for Optometry (a practice checklist to assure Health Boards of quality) and Workforce reporting (to help plan service and training).

**This second 2024/5 Service Insight is regarding WGOS1 Smoking Cessation. The impact will be;**

- To better understand your experiences asking patients whether they smoke.
- To understand how patients are being supported in smoking cessation.
- To identify any further resources that we can provide to support the profession.
- To communicate findings outside of Wales and add to the research and knowledge pool in this field.
