#### Dear Colleague

GENERAL OPHTHALMIC SERVICES AND EYE EXAMINATION SERVICES FEES, DOMICILIARY FEES, PAYMENTS FOR CONTINUED PROFESSIONAL DEVELOPMENT, PRE-REGISTRATION SUPERVISORS GRANT, PRACTICE GRANT FOR COLLEGE OF OPTOMETRISTS PROFESSIONAL HIGHER CERTIFICATE IN GLAUCOMA AND QUALITY FOR OPTOMETRY.

#### **Summary**

- 1. I am writing to notify you of the:
- a) General Ophthalmic Services (NHS Sight Test) Fee, Eye Examination Services Fees and domiciliary fees from 21 October 2024;
- b) Optometry Collaborative Cluster Payments from 21 October 2024;
- c) Hospital Eye Service maximum patient charge from 21 October 2024;
- d) Continued Professional Development payment for 2023 and 2024 calendar years respectively; and
- e) Grant payable to supervisors of pre-registration trainees;
- f) Practice Grant for College of Optometrists, Higher Professional Certificate in Glaucoma;
- g) Quality for Optometry.
- Please could you bring this information to the attention of all staff dealing with primary care ophthalmic services, i.e. dispensing opticians, optometrists, ophthalmic medical practitioners and other staff concerned with the hospital eye service.
- 3. Local Health Boards should ensure that copies of this letter are distributed to all dispensing opticians, optometrists and ophthalmic medical practitioners in their areas.
- 4. The determination and directions to Local Health Boards contained in Annex 2 to this letter are made in the exercise of the Welsh Minister's powers in sections 12(3), 76, 77 and 203(9) and (10) of the National Health Service (Wales) Act 2006.

## General Ophthalmic Services and Eye Examination Services Fees / NHS Domiciliary Fee

5. General Ophthalmic Services (NHS Sight Test) Fee has increased for 2024/25 and is set at £44.00, effective from 21 October 2024.



- 6. The Eye Examination Service Fee effective from 21 October 2024 is WGOS 2 Band 1 set at £71.63; WGOS 2 Band 2 set at £54.23; and WGOS 2 Band 3 set at £26.61.
- 7. For NHS domiciliary visits carried out on or after 21 October 2024, the fee is £40.57 for the first and second patients and £10.15 for third and subsequent patients.
- 8. Payments must be made in accordance with the Statement of General Ophthalmic Services Remuneration and Fee Directions at Annex 2.

## **Optometry Collaborative Cluster Payments from 20 October 2023**

9. To ensure consistency of engagement across Wales, Optometry Cluster Collaboratives are being established with a duty for each optometry practice within the cluster to engage through participating in the Optometry Professional Collaborative meetings. Each optometry practice must attend at least 4 meetings per financial year and is to be reimbursed for attending each meeting, up to a maximum of four meetings. Payments must be made in accordance with the Statement of General Ophthalmic Services Remuneration and Fee Directions at Annex 2.

## Maximum Patient Charge within the Hospital Eye Service

10. The Hospital Eye Service maximum charges will continue to be: £70.00 for single vision lenses; and £113.80 in any other case.

#### Payments for Continued Professional Development (CPD)

- 11. The payments in respect of continuing professional development undertaken in 2023 and 2024 by optometrists, dispending opticians and ophthalmic medical practitioners without another medical appointment (i.e. who do no other remunerative work but Primary Ophthalmic Services) are set out in the Statement of General Ophthalmic Services Remuneration and Fee Directions at Annex 2. Further guidance will follow in due course from NHS Wales Shared Services Partnership (NWSSP).
- 12. Payments will be made in respect of claims made by dispensing opticians, optometrists and ophthalmic medical practitioners relating to CPD training undertaken during the year from 1 January to 31 December 2023 and 1 January to 31 December 2024 respectively as set out in Annex 2. Payments must be made in accordance with the Statement of General Ophthalmic Services Remuneration and Fee Directions at Annex 2.

#### **Pre-registration supervisors grant**

13. The allowance paid to supervisors of pre-registration trainees has increased to £7,500. Claims from trainers taking on pre-registration trainees on or after 1 September 2024 should be paid at this rate.

#### Practice Grant (WGOS 4 Higher Professional Certificate in Glaucoma)

14. To encourage contractors to release optometrists to complete the clinical requirements for the College of Optometrists Professional Higher Certificate in Glaucoma optometry practices will be reimbursed for each clinical session an optometrist attends for the

purposes of attaining the qualification, up to a maximum of forty sessions (20 days). Payments must be made in accordance with the Statement of General Ophthalmic Services Remuneration and Fee Directions at Annex 2.

#### **Quality for Optometry**

15. To further improve governance arrangements formal Quality Improvement standards have been introduced for Optometry in Wales. Robust quality improvement systems are necessary to measure and ensure the highest quality outcomes for patients in Wales. As part of the scheme contractors are required to complete a National Workforce Reporting tool outlining the workforce in their practice; make a return of the Quality for Optometry (QO) governance template; participate in and complete three audits (clinical and non-clinical) annually; and undertake mandatory training as required. Payments must be made in accordance with the Statement of General Ophthalmic Services Remuneration and Fee Directions at Annex 2.

#### Guidance

- 16. A copy of this letter and the Annexes will be placed on the NWSSP website at Ophthalmic Services NHS Wales Shared Services Partnership.
- 17. If optometrists, dispensing opticians or ophthalmic medical practitioners have any queries then they should contact their Local Health Board or Primary Care Services at NWSSP.

## STATEMENT OF GENERAL OPHTHALMIC SERVICES REMUNERATION AND FEE DIRECTIONS

The Welsh Ministers, in exercise of the powers conferred by sections 12(3), 76, 77 and 203(9) and (10) of the National Health Service (Wales) Act 2006(1) ("the 2006 Act") make the following determination as to the remuneration to be paid to those providing general ophthalmic services and give the following directions in respect of the remuneration to be paid to those providing eye examination services under the National Health Service (Ophthalmic Services) (Wales) Regulations 2023 and other fees payable to those providing these services.

Before making this determination under section 76 and 77 of the 2006 Act in relation to the remuneration to be paid to those providing general ophthalmic services, the Welsh Ministers consulted with the organisation recognised by them as representing contractors providing general ophthalmic services.

#### Part 1

Title, Commencement and Interpretation

## Title, commencement and interpretation

- 1.—1) The title of these combined directions and determination is the Statement of General Ophthalmic Services Remuneration and Fee Directions ("the Statement and Fee Directions").
- (2) The Statement and Fee Directions come into force on 7 February 2025 and take effect from 21 October 2024.
  - (3) In these Statement and Fee Directions-
    - "contact lens optician" means a person who is registered as a dispensing optician in the register maintained under section 7 of the Opticians Act 1989 (register of opticians) with a contact lens specialty entry;
    - "contractor" means a person who has undertaken to provide Primary Ophthalmic Services and whose name is included in the ophthalmic list;
    - "corporate optician" means a body corporate registered in the register of bodies corporate maintained under section 9 of the Opticians Act 1989(2), which is carrying on business as an optometrist;
    - "CPD" means Continuing Professional Development;
    - "dispensing optician" means a person who is registered as a dispensing optician in the register maintained under section 7 of the Opticians Act 1989 (register of opticians);
    - "Eye Examination Services" means the services which a contractor must provide under paragraph 24 of Schedule 4 to the National Health Service (Ophthalmic Services) (Wales) Regulations 2023;

"General Ophthalmic Services" means the services which a contractor must provide under paragraph 23 of Schedule 4 to the National Health Service (Ophthalmic Services) (Wales) Regulations 2023;

"GOS" means General Ophthalmic Services;

"Independent Prescribing Optometrist" means a person registered as an optometrist in the register maintained under section 7 of the Opticians Act 1989 (register of opticians) with an independent prescribing speciality entry;

"Local Health Board" means a Local Health Board established by way of an order under section 11(2) of the National Health Service (Wales) Act 2006;

"ophthalmic list" means the list defined in regulation 10(2)(a) of the National Health Service (Ophthalmic Services) (Wales) Regulations 2023;

"ophthalmic medical practitioner" means a person recognised under regulation 9 of and Schedule 2 to the National Health Service (Ophthalmic Services) (Wales) Regulations 2023;

"optometrist" means a person registered in the register of optometrists maintained under section 7 (register of opticians) of the Opticians Act 1989;

"optometry collaborative" a group of contractors providing primary ophthalmic services within the geographic area of the same primary care cluster;

"optometric lead" means the person elected by an optometry collaborative to represent it within a primary care cluster;

"patient" means a person for whom a contractor has agreed to provide general ophthalmic services or eye examination services;

"primary care cluster" means a group of health and social care providers that have agreed to work collaboratively to delivery primary care services across a specified geographic area:

"Primary Ophthalmic Services" means, collectively-

- (i) General Ophthalmic Services, and
- (ii) Eye Examination Services.

"relevant optometry collaborative" means the optometry collaborative in whose area the contractor provides primary ophthalmic services;

"WGOS 2 accredited contact lens optician" means a contact lens optician who has been accredited by Health Education and Improvement Wales to undertake elements of the eye examination service.

#### Part 2

General Ophthalmic Services and Eye Examination Services Fees

## **General Ophthalmic Services and Eye Examination Services Fees**

- 2. The fee payable to a contractor for providing General Ophthalmic Services is £44.00.
- **3.**The eye examination fees payable to a contractor for providing Eye Examination Services are as follows: WGOS 2 Band 1 set at £71.63; WGOS 2 Band 2 set at £54.23; and WGOS 2 Band 3 set at £26.61.

#### **Domiciliary visit fees**

- **4.** The fees payable to a contractor, for an NHS domiciliary visit carried out by the contractor are—
  - (a) £40.57 first and second patients; and
  - (b) £10.15 for third and subsequent patients.

## Conditions attached to payment of General Ophthalmic Services, Eye Examination Services and domiciliary visit fees

- **5.** A claim for General Ophthalmic Services, Eye Examination Services and domiciliary visit fees, or any part thereof, is only payable if the contractor satisfies the following conditions—
  - (a) the contractor must make available to the Local Health Board any information which the Local Health Board does not have but needs, and the contractor either has or could reasonably be expected to obtain, in order to calculate the payment due to the contractor.
  - (b) the contractor must maintain accurate records of all General Ophthalmic Services, Eye Examination Services and domiciliary visit activity undertaken, including emergency and urgent eye care, and
  - (c) all information supplied by the contractor to the Local Health Board pursuant to or in accordance with this paragraph must be accurate to the contractor's best knowledge and belief.
- **6.** If the contractor breaches any of the conditions in paragraph 5, the Local Health Board may, in appropriate circumstances, withhold payment of, or any part of, a General Ophthalmic Services, Eye Examination Services or domiciliary visit fee that is otherwise payable.

#### Part 3

#### CPD Allowance 2023

#### 7.— (1) In this paragraph—

- "Relevant year" means the year beginning with 1 January 2023 and ending with 31 December 2023.
- (2) Subject to sub-paragraph (9), the Local Health Board must pay a CPD allowance to an optometrist, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year and maintained their professional registration for that period in the relevant year;
  - (b) has undertaken appropriate continuing professional development during the relevant year; and
  - (c) complies with sub-paragraphs (11) and (12).
- (3) Subject to sub-paragraph (9), the Local Health Board must pay a CPD allowance to an Independent Prescribing Optometrist, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year and maintained their professional registration for that period in the relevant year;
  - (b) has undertaken appropriate continuing professional development relevant to their higher qualification during the relevant year;
  - (c) complies with sub-paragraphs (11) and (12) and
- (4) Subject to sub-paragraph (9), the Local Health Board must pay a supplement to an optometrist holding the College of Optometrists professional certificate in medical retina or professional higher certificate in medical retina, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year; maintained their professional registration for that period in the relevant year; and
  - (b) has undertaken appropriate continuing professional development relevant to their higher qualification during the relevant year, and
  - (c) complies with sub-paragraphs (11) and (12).
- (5) Subject to sub-paragraph (9), the Local Health Board must pay a supplement to an optometrist holding the College of Optometrists professional higher certificate in glaucoma or professional diploma in glaucoma, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year; maintained their professional registration for that period in the relevant year;
  - (b) has undertaken appropriate continuing professional development relevant to their higher qualification during the relevant year; and
  - (c) complies with sub-paragraphs (11) and (12).
- (6) Subject to sub-paragraph (9), the Local Health Board must pay a Low Vision supplement to an optometrist who has completed the WGOS 3 Low Vision mandatory additional training delivered by HEIW, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year; maintained their professional registration for that period in the relevant year;
  - (b) has undertaken appropriate continuing professional development relevant to their higher qualification during the relevant year; and

- (c) complies with sub-paragraphs (11) and (12).
- (7) Subject to sub-paragraph (9), the Local Health Board must pay a CPD allowance to an ophthalmic medical practitioner if—
  - (a) during the relevant year their only remunerated medical or optical activity was the conduct of Primary Ophthalmic Services;
  - (b) they were included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year and maintained their professional registration for that period in the relevant year;
  - (c) they have undertaken appropriate continuing professional development during the relevant year; and
  - (d) they comply with sub-paragraphs (11) and (12).
- (8) Subject to sub-paragraphs (9) and (10), the Local Health Board must pay to a contractor a CPD allowance and any applicable Medical Retina or Higher Certificate/Diploma in Glaucoma or Low Vision supplement, where applicable in respect of—
  - (a) each assistant employed by that contractor if the assistant—
    - (i) is an optometrist (other than a corporate optician);
    - (ii) was included in the supplementary list of the Local Health Board to which the contractor makes a claim for a CPD allowance; and
    - (iii) has assisted in the provision of general ophthalmic services and/or eye examination services for a period of at least 6 months during the relevant year and maintained their professional registration for that period for the relevant year; and
    - (iv) has undertaken appropriate continuing professional development during the relevant year;
  - (b) each dispensing optician and contact lens optician employed by that contractor if that dispensing optician or contact lens optician—
    - (i) is employed by a contractor included in the ophthalmic list of the Local Health Board to which the contractor makes a claims for a CPD allowance; and
    - (ii) has undertaken appropriate continuing professional development during the relevant year,

and the contractor complies with sub-paragraphs (11) and (12).

- (9) Only one CPD allowance, together with any applicable Medical Retina and/or Higher Certificate in Glaucoma and/or Low Vision supplement, may be claimed in respect of any one person.
- (10) Where an assistant or dispensing optician is employed by two or more contractors, the CPD allowance will be paid to the contractor which the assistant or dispensing optician nominates for the purpose of payment of the CPD allowance under this determination.
- (11) A claim for a CPD allowance (together with any applicable supplement) must be made in writing on the form approved for this purpose by Welsh Ministers.
- (12) A separate claim form must be completed for each CPD allowance (together with any applicable supplement) claimed.

- (2) Subject to sub-paragraph (9), the Local Health Board must pay a CPD allowance to an optometrist, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year and maintained their professional registration for that period in the relevant year;
  - (b) has undertaken appropriate continuing professional development during the relevant year; and
  - (c) complies with sub-paragraphs (11) and (12).
- (3) Subject to sub-paragraph (9), the Local Health Board must pay a CPD allowance to an Independent Prescribing Optometrist, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year and maintained their professional registration for that period in the relevant year;
  - (b) has undertaken appropriate continuing professional development relevant to their higher qualification during the relevant year, and
  - (c) has examined and appropriately managed patients relevant to their higher qualification through WGOS 5 services for a period of at least 3 months during the relevant year; and
  - (d) complies with sub-paragraphs (11) and (12).
- (4) Subject to sub-paragraph (9), the Local Health Board must pay a CPD allowance to a Medical Retina optometrist holding the College of Optometrists professional certificate in medical retina or professional higher certificate in medical retina, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year; maintained their professional registration for that period in the relevant year; and

- (b) has undertaken appropriate continuing professional development relevant to their higher qualification during the relevant year, and
- (c) has examined and appropriately managed patients relevant to their higher qualification through WGOS 4 services for a period of at least 3 months during the relevant year; and
- (d) complies with sub-paragraphs (11) and (12).
- (5) Subject to sub-paragraph (9), the Local Health Board must pay a CPD allowance to an optometrist holding the College of Optometrists professional higher certificate in glaucoma or professional diploma in glaucoma, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year; maintained their professional registration for that period in the relevant year; and
  - (b) has undertaken appropriate continuing professional development relevant to their higher qualification during the relevant year; and
  - (c) has examined and appropriately managed patients relevant to their higher qualification through WGOS 4 or 5 services for a period of at least 3 months during the relevant year; and
  - (d) complies with sub-paragraphs (11) and (12).
- (6) Subject to sub-paragraph (9), the Local Health Board must pay a CPD allowance to an optometrist who has completed the WGOS 3 Low Vision mandatory additional training delivered by HEIW, other than a corporate optician, if the optometrist—
  - (a) was included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 6 months during the relevant year; maintained their professional registration for that period in the relevant year; and
  - (b) has undertaken appropriate continuing professional development relevant to their higher qualification during the relevant year; and
  - (c) has examined and appropriately managed patients relevant to their higher qualification through WGOS 3 services for a period of at least 3 months during the relevant year; and
    - (d) complies with sub-paragraphs (11) and (12).
- (7) Subject to sub-paragraph (9), the Local Health Board must pay a CPD allowance to an ophthalmic medical practitioner if—
  - (a) during the relevant year their only remunerated medical or optical activity was the conduct of Primary Ophthalmic Services;
  - (b) they were included in the ophthalmic list of the Local Health Board to which they make a claim for a CPD allowance for a period of at least 3 months during the relevant year and maintained their professional registration for that period in the relevant year;
  - (c) they have undertaken appropriate continuing professional development during the relevant year; and
  - (d) they comply with sub-paragraphs (11) and (12).
- (8) Subject to sub-paragraphs (9) and (10), the Local Health Board must pay to a contractor a CPD allowance and any applicable Low Vision, Medical Retina or Higher Certificate/Diploma in Glaucoma supplement, where applicable in respect of—
  - (a) each assistant employed by that contractor if the assistant—
    - (i) is an optometrist (other than a corporate optician);

- (ii) was included in the supplementary list of the Local Health Board to which the contractor makes a claim for a CPD allowance; and
- (iii) has assisted in the provision of general ophthalmic services and/or eye examination services for a period of at least 6 months during the relevant year and maintained their professional registration for that period for the relevant year;
- (iv) has examined and appropriately managed patients relevant to their higher qualification through WGOS 3, 4 or 5 services for a period of at least 3 months during the relevant year; and
- (v) has undertaken appropriate continuing professional development during the relevant year;
- (b) each dispensing optician and contact lens optician employed by that contractor if that dispensing optician or contact lens optician—
  - (i) is employed by a contractor included in the ophthalmic list of the Local Health Board to which the contractor makes a claims for a CPD allowance; and
  - (ii) has undertaken appropriate continuing professional development during the relevant year,
  - (iii) has examined and appropriately managed patients relevant to their higher qualification through WGOS 3 services for a period of at least 3 months during the relevant year; and

the contractor complies with sub-paragraphs (10) and (11).

- (9) Only one CPD allowance, together with any applicable Medical Retina and/or Higher Certificate/Diploma in Glaucoma supplement, may be claimed in respect of any one person.
- (10) Where an assistant or dispensing optician is employed by two or more contractors, the CPD allowance will be paid to the contractor which the assistant or dispensing optician nominates for the purpose of payment of the CPD allowance under this determination.
- (11) A claim for a CPD allowance (together with any applicable supplement) must be made in writing on the form approved for this purpose by Welsh Ministers.
- (12) A separate claim form must be completed for each CPD allowance (together with any applicable supplement) claimed.

#### Part 5

## Optometry collaborative fees

- **9.** —(1) Subject to paragraph (2), the Local Health Board must pay a contractor the sum of £277.10 if-
  - (a) the contractor is included in that Local Health Board's ophthalmic list, and
  - (b) the contractor attends a meeting of the relevant optometry collaborative.
  - (2) No more than £1,108.40 may be paid to a contractor under sub-paragraph (1) in any one financial year.
  - —(1) Subject to paragraph (2), the Local Health Board must pay a contractor the sum of £2,200 in respect of an assistant employed by that contractor that is elected as an optometric lead by an optometry collaborative to represent it within a primary care cluster.
  - (2) No more than £2,200 may be paid to a contractor under sub-paragraph (1) in any one financial year.

#### Part 6

- **10.** Practice Grant (WGOS 4 Higher Professional Certificate in Glaucoma)
- (1) Subject to paragraph (2), the Local Health Board must pay a contractor the sum of £125 per session (£250 per day) if-
- (a) the contractor is included in that Local Health Board's ophthalmic list, and
- (b) the contractor releases an optometrist undertaking clinical placements for the purpose of gaining the College of Optometrists Professional Higher Certificate in Glaucoma.
- (2) No more than £5,000 may be paid to a contractor under sub-paragraph (1) in any one financial year.

#### Part 7

### **Quality for Optometry**

- 11. (1) The 2024/25 Quality for Optometry Scheme will include the following elements:
  - Wales National Workforce Reporting System (Monthly submissions)
  - Quality improvement and governance self-assessment (annual return)
  - Undertaking and submission of Audits (Maximum of three per financial year)
  - Mandatory training (As required)
- (2) Subject to paragraph (3), the Local Health Board must pay a contractor the sum of
- (3) £5000 paid in quarterly instalments of £1250, if-
  - (a) the contractor is included in that Local Health Board's ophthalmic list, and
  - (b) the contractor completes all elements of the Quality for Optometry.
- (4) No more than £5,000 may be paid to a contractor under sub-paragraph (2) in any one financial year.

#### PART 8

#### REVOCATIONS

**12.** The Statement Of General Ophthalmic Services Remuneration and Fee Directions which came into force on 20 October 2023 is revoked.
